DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE.

The Masonic Hall is a rectangular two-story brick veneer lodge building with a hipped composition shingle roof. The building faces east and is three bays wide and five bays deep. An entrance with double leaf doors and a twelve-light transom is centered at the façade beneath a hipped hood. The doors are wood with six lights over three panels and the transom is an aluminum replacement. A modern wood handicapped ramp extends from the entrance over simple set of masonry steps. The entrance is flanked to either side by double aluminum twelve-over-twelve light replacement windows. Similar windows correspond at the second floor level. There is no opening at the upper level above the entrance and a tall sign at that location reads: Fraternity/145/O.E.S./389." The exterior wall is faced with brick veneer with corner pilasters and a low concrete foundation is exposed. A simple boxed cornice has been clad with aluminum. A datestone at the southern pilaster reads: "Fraternity Lodge/No. 145/Free and Accepted Masons/of Alabama/Chartered 1853/A.L. 5962 – A.D. 1962/Arlis R. Fant Grand Master/April 21, 1962."

The south elevation is similar in design to the façade and has a similar single entrance at its fourth bay (from the east) with a brick and concrete stoop and stairs. The three eastern bays of the first and second floor levels have windows similar to those at the façade. The western bay has a smaller six-over-six window at each level. A sign, similar to the one at the façade but smaller, is set above the entrance. The west elevation is similar in design to the other elevations. A former entrance, now bricked in, at the center bay retains a simple hipped hood. The entrance is flanked to the north by two single window openings and to the south by a single window opening, all of which have been bricked in.

entrance bay hipped door hood; central entrance at facade with double leaf doors and transom flanked by double aluminum 9/9 double hung sash windows, similar double 6/6 windows at upper level, similar windows at side elevations; exposed brick veneer exterior elevations; concrete slab foundation. Two single windows similar to those at the south elevation are evenly spaced at the second floor level. The north elevation is similar to the south elevation except that it has no entrance.

The interior has a dining hall and kitchen at its first floor and a meeting hall at its second floor. The first floor originally had a stage at it west end. The rectangular proscenium has been walled off and a kitchen constructed in the former stage area. The dining hall to the east retains an exposed beaded board ceiling. Modern plywood paneling covers all four walls and the floor has been covered with vinyl. Finishes within the kitchen are modern. A staircase rises at the southwest corner within a narrow hallway to the south of the kitchen. Rising along the west to the second floor, the stair leads to an anteroom that is roughly the same width as the stage/kitchen below. The anteroom has a textured sheetrock ceiling, plywood paneled walls over historic beaded board wainscoting, and carpet floor finishes. The large lodge hall to the east has similar finishes.

The building retains its overall historic design and appearance despite modifications that included the replacement of exterior windows (circa 1980), the reworking of the stage/kitchen area, and the application of modern interior finishes. The building is in generally good condition.

STATEMENT OF SIGNIFICANCE

The Blountsville Masonic Hall is historically significant for its role as a fraternal lodge hall from 1933 through the present and for having served as the town's city hall from 1933 until the mid-1950s. The building has served as one of the centers of community activity since the time of its construction. Although altered, the overall historic appearance of the building retains integrity. The period of significance for the resource is from 1933, the date of its construction, through circa 1955, when city hall moved to another location.

The Masonic Hall was constructed in 1933 for the lodge No. 145 of the Free and Accepted Masons of Alabama. The lodge was chartered in 1858. From 1933 through the mid 1950s, the building also served as Blountsville's City Hall. The cornerstone for the building was installed in 1962 with R. Fant then serving as Grand Master.





General Location Maps




Siteplan (Not to Scale)




