The first record of Union Church begins - "A Journal of the Church at Union Meeting House Ala."

Constituted with six members the 18th of April, 1835 by Elders

John Barnett and Peter Hughs. Presbytary on the Principles of the

Elder Peter Hughs was elected as the first Minister - Frederick Pickett was the first Deacon -\*.

From 1835 until today, the Pickett family has been a mainstay of the church. Deacon Frederick Pickett led church councils for many years. Today, 1961 Miss Laure Pickett, his grand daughter is the sole remaining member of Union Church. Miss Laure is guardian of all church records. She lives with her sister, Miss Mary Pickett, in High Ridge - address Fitzpatrick. (Because of the close connection of the Pickett family to Union Church, it seems well to pause to review the early Pickett family History - See on another sheet.)

Frederick Pickett came to Pike County, now Bullock (a portion of Pike County) from Dublin County, N. C. in 1832-33. Joined Union Church by letter from Baptist Church of Christ, Meadow Meeting House, Dublin Co., N. C. Died April 13th, 1866.

Other early members of Union Church are recorded below:

Hugh F. Pickett, ordained as Baptist preacher Oct. 1858 and unanimously chosen pastor of Union Church 1859 - resigned 1861 to enter Confederate Army and died in service May 17th, 1862.

Andrew Jackson Pickett, son of Frederick Pickett, joined Union Church Sept. 4th, 1863 and was a member until his death Aug. 25th, 1911, serving for many years as Deacon or Clerk.

Alfred & Elizabeth Tilory by letter from Baptist Church of Christ Fellowship of Pike County, Ala. Dismissed from Union Church by letter 1837.

James Murry by letter from Baptist Church of Christ, Meadow Meeting House, Dublin, N. C. Dismissed by letter July, 1840.

Anderson Medlock from Pike County, Ala. - Mount Zenie(?).

Sarah Mitchell by letter from Fellowship Church, Pike County, Ala.

James and Mary Andrews by letter from Muddy Creek Church, Dublin, N. C. (County).

Mary Stubbs by letter from church called Salem, in Marlborough District of South Carolina.

After elder Hughs some of the members were:

The last minister was Henry Dean.

In 1902 after much discussion on Predestination and Associations, 17 members withdrew from Union Church to form Concord Church at China Grove, Ala. (about five miles from Union Church)

Membership count for Union Church was:

1857 33 members 1896 71 members 1904 46 members

1921 7 members 1961 1 member

The last meeting held at the Union Church was 1925.

Church property consisted of five acres, more or less. Was purchased from J. H. Crowder, the deeds show this purchase to be true, for Fifteen (\$15.00) dollars in 1891. Mr. Crowder had previously acquired this land from James M. Hughes or Hughs.

The first church was of logs. This building, as well as the second, was on the same side of road as the cemetery. Todays building is across the road from the cemetery.

The building Committee for the third building (standing today) was composed of H. J. Matthews, Fred Burk, W. W. Costen and Andrew J. Pickett - date 1889.

This third building stands today, kept in good condition and repair by descendents of members of Union Church.

It is surrounded by pines and nearby is the old spring, so necessary in days of early settlement.

The church cemetery is very large, with many graves. This suggests that it was used as a community cemetery. Many have been burried there who were not members of Union Church (which includes my grandfather and grandmother and children, Mr. and Mrs. Chas. Baker Collins. They lived near Union Church and this church was convenient to them )


