

80. WestPoint Pepperell's Personnel Office (3110 - 23rd Drive)  
One story brick building with glass panel and door front entrance, flat roof, single pane windows, side entrance. Contains multiple offices used for personnel and industrial medical services.  
NOTE: This site once contained a village theatre and school kindergarten. The theatre was torn down and the kindergarten was moved to Site #64.
81. Bob Harding Elementary School (3301 - 23rd Drive)  
The original wooden building was torn down and replaced with a flat roof brick school building.
82. Gymnasium (3307 - 23rd Drive),  
Brick structure used for school activities, sports, and is also used as WestPoint Pepperell's Fitness Center.
84. WestPoint Pepperell's Research Division (3300 - 23rd Drive)  
One story brick and glass building, flat roof, front entrance of glass panels and doors with drive through cover. Building contains multiple offices and laboratories used in textile research.
85. WestPoint Pepperell's Engineering Building-Shawmut Cafeteria (2200 - 35th Place),  
This was originally a clapboard building with multi-paned windows, piers (now continuous). At present, it is a brick building, new windows, room addition on side and back.
90. Dykes House (3406 - 35th Place),  
One story clapboard cottage, half width front porch, pyramid roof, 6/6 windows, 2 interior chimneys, piers. Original house torn down with brick house erected with hip roof, 2/2 windows.
91. Siggers House (3407 - 35th Place),  
Originally empty lot. Now a brick house, gable roof, 2/2 windows, porch with railing and wrought iron columns, shutters.

96. H. Grady Bradshaw Chambers County Library and Cobb Memorial Archives (3419 - 20th Avenue), 1975-76  
One story contemporary building with flat roof, "Dryvit" siding exterior. Front entrance is glass panels with double glass doors - all recessed in front wall. Building has large room with book displays and reading areas, conference rooms, work rooms and offices, and a large archives section.
101. Underwood House (2102 - 35th Street)  
Original one story clapboard torn down and replaced with one story brick veneer bungalow, gable roof, 2/2 windows, carport and utility room facing front, shed roof with wrought iron trimmed front stoop.
114. Williams House (2204 - 38th Blvd.)  
Original: 3 rooms with central hall, gable roof, one interior chimney, 6/6 windows, half porch with shed roof, clapboard siding, pier foundation.  
Present: House torn down and mobile home moved on lot.
139. Bailey House (2414 - 38th Blvd.)  
Original: 3 rooms, full porch, gable roof, 1 interior chimney, 6/6 windows, clapboard siding, pier foundation.  
Present: House torn down. Garage apartment on rear of lot.
146. Fickey-Jones House (2409 - 37th Street),  
One story clapboard bungalow, 6/6 windows, piers, gable and hip roof, 1 interior chimney, full width front porch, 2 front doors. Original house torn down and rebuilt with wood, 1/1 windows, gable and hip roof, concrete front porch, 1 front door, no chimney.
158. Adamson-Jones House (3606 - 24th Avenue)  
Original: one story clapboard, 6/6 windows, piers, pyramid roof, 2 chimneys, half width front porch.  
Present: House town down. Mobile home with front porch added.

179. Dykes House (2417-A - 36th Street)  
This residence consists of a mobile home permanently moored with roof built over it.
192. Carmichael House (2406 - 35th Street)  
A two -story brick bungalow with barn type roof and one brick exterior chimney on rear of house, 6/6 and 2/2 windows, gable stoop with wooden columns is over front entry.  
NOTE: This site originally contained a clapboard 3 room cottage.
196. Moon House (2402 - 35th Street)  
This site previously contained a one-story clapboard cottage. Now a one-story brick veneer bungalow with hip roof and front entry, double carport, awning-type windows.
243. Hester House (3003 - 29th Blvd.)  
Original: No structure on site.  
Present: Brick house, hip roof, 2/2 windows.
271. Andreasen House (2032 - 29th Blvd.),  
Originally an empty lot. Now has mobile home covered with wood siding, gable roof, deck at rear.
285. King-Cole House (3001 - 24th Avenue)  
Original: One story clapboard, 6/6 windows, pyramid roof, 2 chimneys, original piers, half porch. (Note: was originally facing 30th Street).  
Present: One story brick with carport, 6/6 windows, cement drive, gable and hip roof, now facing 24th Avenue, continuous foundation.
298. Archer Optical (2000 - 30th Street)  
Originally a one story clapboard bungalow, hip roof, 2 interior chimneys, 6/6 windows, full width front porch with banisters, piers (now continuous). Now remodeled. All original doors and windows removed and continuous line of 6/6 windows installed on 2 adjacent sides; 1 outside entrance located on adjacent side. Front entrance covered with gable roof supported by round columns; vinyl siding added; porch enclosed; chimneys removed; interior walls rearranged. (NOTE: Last known residents prior to remodeling were Floyd McElreath preceded by J. T. Tarver.)
302. Shawmut Baptist Church Parsonage (3004 - 22nd Avenue)  
The original one story clapboard burned. Replaced with one story brick; 1/1 windows, gable roof, carport with cement drive.
303. Empty Lot (3007 - 22nd Avenue)  
Owned by Randy Hall. Contained single mobile home which burned.

306. Johnson-Arnett House (3008 - 22nd Avenue)  
Original one story clapboard, 6/6 windows, piers, pyramid roof, 1 interior chimney, half width front porch. House moved to present site from Hwy. 29. Asbestos siding added, new foundation, room added on side with gable roof, room added on back with gable roof, carport and cement drive.
320. Valley Health Department (3205 - 22nd Avenue),  
No original building. Presently a flat roof, brick building with 2/2 windows.
328. Jones-Morgan House (3313 - 21st Avenue)  
One story clapboard, piers, 6/6 windows, chimneys, full width front porch, gable roof. Now a vacant lot - house torn down.
331. Robinson-Edwards House (3308 - 21st Avenue)  
One story clapboard, pyramid roof, piers, 6/6 windows. Presently a one story brick, gable and hip roof, 6/6 windows, continuous foundation.
347. Abney Flower Shop-McGhee House (3203 - 20th Avenue)  
Originally one story clapboard cottage, piers, 6/6 windows, full width front porch, gable roof, 2 interior chimneys. Presently a business -- one story, vinyl siding, 2 solid windows on front, brick on front, carport, shed on back under shed roof, asphalt drive, continuous foundation.  
Note: Moved back to widen Hwy. 29.
355. Butler-Freeman House (3102 - 24th Avenue)  
Original: one story clapboard, 6/6 windows, piers, 2 chimneys, porch across front, gable roof.  
Present: Mobile home (new piers continuous), 1/1 windows (awnings), deck on front, carport on side.



79. Public Playground, School Playground & Social Gatherings Area (23rd Drive), 1908
83. Open Field & Parking Area (23rd Drive), 1908
86. Duffey-McClendon House (3402 - 35th Place), c. 1910  
One story clapboard bungalow, hip roof, 6/6 windows, 2 interior chimneys, piers (now continuous), full width front porch. Asbestos siding added, chimneys removed, 2/2 windows replace original 6/6, porch screened, addition on one side.
87. Floyd-Dishroon House (3403 - 35th Place), c. 1910  
One story clapboard bungalow, gable roof, 6/6 windows, 2 interior chimneys, piers (now continuous), full width front porch with shed roof. Asbestos siding added, 2/2 windows replace original 6/6, addition at rear, concrete porch with iron railings and posts.
88. Reese-Hollis House (3404 - 35th Place), c. 1910  
One story clapboard cottage, half porch, pyramid roof, 2 interior chimneys, 6/6 windows, piers (now continuous). Rooms and carport added on side, 1/1 windows replace original 6/6, porch enclosed.
89. Graben-Dorough House (3405 - 35th Place), c. 1910  
One story clapboard, 4 rooms, gable roof, full width front porch with shed roof, 2 front doors, 2 interior chimneys, piers (now continuous), 6/6 windows. Rooms and carport added on side, 1/1 windows, vinyl siding added.
92. Strong-Waller House (3408 - 35th Place), c. 1910  
One story clapboard bungalow, full width front porch, hip roof, 2 interior chimneys, 6/6 windows, piers (now continuous). Vinyl siding added over clapboard, 1/3 of porch enclosed, some awning-type windows added.

93. Crowe-Broach House (2005 - 35th Street), 1908  
One story clapboard cottage, hip roof, 2 interior chimneys, full width front porch with banisters, 6/6 windows, piers (now continuous). Original clapboard covered with aluminum siding; 2 rooms added to rear under gable roof; porch screened and metal awnings added to porch and windows.
94. Wallace-Butts House (2003 - 35th Street), 1908  
One story clapboard cottage, pyramid roof, 2 interior chimneys, half width front porch, 6/6 windows, piers (now continuous). Front porch now enclosed and carport with gable roof added to one side; asbestos shingle siding; awning windows replace original windows.
95. Hooks-Baggett House (2001 - 35th Street), 1908  
One story clapboard cottage, hip roof, 2 interior chimneys, 6/6 windows, full width front porch with banisters, piers (now continuous). 2/2 windows with shutters replace original windows; front porch screened and metal awning added; 2 rooms under gable roof added at rear; 1 chimney removed.
97. Lanier-Cooper House (2002 - 35th Street), 1908  
One story clapboard cottage, hip roof, 2 interior chimneys, 6/6 windows, full width front porch with banisters, piers (now continuous). Front porch has been enclosed.
98. Land-Hill House (2004 - 35th Street), 1908  
One story clapboard cottage, hip roof, 2 interior chimneys, 6/6 windows, full width front porch with banisters, piers (now continuous). One chimney removed; carport added to rear.
99. Oliver-Walters-Hooks House (2006 - 35th Street), 1908  
One story clapboard cottage, pyramid roof, 2 interior chimneys, 6/6 windows, half width front porch with banisters, piers (now continuous). Front porch now enclosed with stoop added, clapboard covered with aluminum siding; attic made into room with dormers on front and back; both chimneys removed.
100. Poe-Smith House (2008 - 35th Street), 1908  
One story clapboard cottage, hip roof, 2 interior chimneys, 6/6 windows, full width front porch, piers (now continuous). Vinyl siding covers clapboard; front porch screened; metal awnings added to porch and windows.
102. Hall-Smith House (2104 - 35th Street), 1908  
One story clapboard cottage, hip roof, 2 interior chimneys, full width front porch with banisters, 6/6 windows, piers (now continuous). Front porch now enclosed; gable roof stoop with wrought iron columns added; clapboard covered with vinyl siding; 2/2 windows replace original 6/6.

103. Fetner-McCarthy House (2106 - 35th Street), 1908  
One story clapboard cottage, pyramid roof, 2 interior chimneys, half width front porch, 6/6 windows, piers (now continuous). Front porch now enclosed; shed roof stoop added; clapboard covered with aluminum siding; 2/2 windows replace original 6/6.
104. Cox House (2107 - 35th Street), 1908  
One story clapboard cottage, gable roof, 2 interior chimneys, 6/6 windows, full width front porch with shed roof, piers (now continuous). Clapboard covered with aluminum siding; 1/1 and 2/2 windows replace original 6/6; 1 chimney removed.
105. Carmack-Kennington House (2108 - 35th Street), 1908  
One story clapboard cottage, hip roof, 2 interior chimneys, full width front porch with banisters, 6/6 windows, piers (now continuous). One room under hip roof added to side; clapboard covered with aluminum siding; front porch screened; metal awnings added to porch and windows.
106. Reese-Johnson House (2109 - 35th Street), 1908  
One story clapboard cottage, gable roof, 2 interior chimneys, 6/6 windows, full width front porch with shed roof, piers (now continuous). 2/2 windows replace original 6/6 and 1 chimney has been removed.
107. Dollar-Whitlow House (2110 - 35th Street), 1908  
One story clapboard cottage, hip roof, 2 interior windows, 6/6 windows, full width front porch, piers (now continuous). Front porch has been screened; 2/2 windows with shutters replace original ones.
108. Lashley-Smith House (3502 - 22nd Avenue), 1908  
One story clapboard cottage, 6/6 windows, piers (now continuous), gable roof, 2 interior chimneys, full width front porch. Back porch now enclosed; carport added on side.

109. Hendrix House (3504 - 22nd Avenue), 1908  
One story clapboard cottage, 6/6 windows, piers (now continuous), gable roof, 2 interior chimneys, full width front porch. Vinyl siding added; 1/1 and 2/2 windows; room added on back with gable roof; front porch enclosed; stoop and steps added.
110. Crenshaw-Smith House (3506 - 22nd avenue), 1908  
One story clapboard cottage, piers (now continuous), 6/6 windows, 2 interior chimneys, gable roof, full width front porch.
111. Shawmut Mill Reservoir (38th Blvd.), 1908  
Used for auxiliary fire protection.
112. Terry-Daniel House (2200 - 38th Blvd.), 1910  
One story clapboard cottage with central hall under gable roof, half width front porch with shed roof, 6/6 windows, 1 interior chimney, piers (now continuous). Rooms added, porch enclosed, Masonite siding added, chimney removed, some 2/2 windows, some awning type windows.
113. Boyd-Brandenburg House (2202 - 38th Blvd.), 1910  
One story clapboard cottage with central hall, 6/6 windows, gable roof, one interior chimney, half porch with shed roof, piers. Porch now enclosed, vinyl siding added, pier and continuous foundation, some 2/2 windows, very homemade porch added.
115. Williams-Daniel House (2206 - 38th Blvd.), 1910  
One story clapboard cottage with central hall, 6/6 windows, gable roof, 1 interior chimney, half porch with shed roof, piers. Some 2/2 windows replace 6/6, some piers continuous.
116. Wallace House (2208 - 38th Blvd.), 1910  
One story clapboard cottage with central hall, 6/6 windows, gable roof, 1 interior chimney, half porch with shed roof, piers. Asbestos shingle siding added, some piers now continuous, porch enclosed, chimney removed, 2/2 windows replace 6/6.
117. Hadaway House (2210 - 38th Blvd.), 1910  
One story clapboard cottage with central hall, gable roof, 1 interior chimney, 6/6 windows, half porch with shed roof, piers. Vinyl siding added, porch enclosed, 2/2 windows replace 6/6, some piers now continuous.

118. Matthews-Whitaker House (2212 - 38th Blvd.), 1910  
One story clapboard cottage with central hall, gable roof, half porch with shed roof, 6/6 windows, 1 interior chimney, piers. Vinyl siding added, 2/2 windows replace 6/6, chimney removed, some piers now continuous.
119. McDonald-Sharpe House (2214 - 38th Blvd.), 1910  
One story clapboard cottage, gable roof, full width front porch, 1 interior chimney, 6/6 windows, piers. Porch enclosed, chimney removed, 1/1 windows replace 6/6, aluminum siding added, some piers now continuous.

120. Milner House (3608 - 23rd Avenue), c. 1920  
One story clapboard bungalow, gable roof, 6/6 windows, full width front porch, 2 interior chimneys, piers (now continuous). Asbestos siding added, 1 chimney removed, 2/2 windows replace original ones, porch boarded up half way with top half screened.
121. Perryman House (3606 - 23rd Avenue), c. 1920  
One story clapboard bungalow, full width front porch, 6/6 windows, gable roof, 2 interior chimneys, piers (now continuous). Asbestos siding added, chimneys removed, some 2x2 windows replace 6/6, porch boarded and screened.
122. Rogers-Smith House (3604 - 23rd Avenue), c. 1920  
One story clapboard bungalow, full width front porch, 6/6 windows, gable roof, 1 interior chimney, piers (now continuous). Asbestos siding added, chimney removed, concrete porch with iron railings and posts replace original porch.
123. Plair-Smith House (3602 - 23rd Avenue), c. 1920  
One story clapboard bungalow, full width front porch, gable roof, 6/6 windows, 1 interior chimney, piers (now continuous). Masonite siding added, porch enclosed, 2/2 windows replace 6/6, stoop added on front.
124. Duffey-McDonald House (3600 - 23rd Avenue), c. 1920  
One story clapboard bungalow, full width front porch, gable roof, 6/6 windows, 1 interior chimney, piers (now continuous). Aluminum siding added, porch boarded and screened.
125. Jones House (3601 - 23rd Avenue), c. 1920  
One story clapboard bungalow, full width front porch, gable roof, 6/6 windows, 1 interior chimney, piers (now continuous). Asbestos siding added, chimney removed, windows replaced with 2/2, porch screened.
126. Scott House (3603 - 23rd Avenue), c. 1920  
One story clapboard bungalow, full width front porch, gable roof, 6/6 windows, 1 interior chimney, piers (now continuous). Asbestos siding added, windows replaced with 2/2, addition at rear, porch screened.
127. Newby House (3605 - 23rd Avenue), c. 1920  
One story clapboard bungalow, full width front porch, gable roof, 6/6 windows, 1 interior chimney, piers (now continuous). 2/2 windows replace 6/6, porch screened.
128. Earles-Crowe House (3607 - 23rd Avenue), c. 1920  
One story 4-room clapboard, 6/6 windows, gable roof, interior chimney, full width front porch, piers (now continuous). Asbestos siding added, porch screened and windows replaced with 2/2.

129. Earles House (3609 - 23rd Avenue), c. 1920  
One story clapboard bungalow, full width front porch, 6/6 windows, gable roof, 1 interior chimney, piers (now continuous). Aluminum siding added, some 2/2 windows, chimney removed, rooms added upstairs, deck added at rear, concrete porch replaces original one.
130. Crowder-Mangrum House (2304 - 38th Blvd.), 1910  
One story clapboard cottage, full width front porch, gable roof, 1 interior chimney, 6/6 windows, piers. Chimney removed. pier and continuous foundation.
131. Walters House (2306 - 38th Blvd.), 1910  
One story clapboard cottage, full width front porch, gable roof, 1 interior chimney, 6/6 windows, piers (now continuous). Vinyl siding added, 2/2 windows replace original ones, room added on side.
132. Dodgen House (2308 - 38th Blvd.), 1910  
One story clapboard cottage, full width front porch, gable roof, 1 interior chimney, 6/6 windows, piers. Vinyl siding added, 2/2 windows replace original 6/6, piers and continuous foundation.
133. Dykes-Lyons House (2310 - 38th Blvd.), 1910  
One story clapboard cottage, full width front porch, gable roof, 1 interior chimney, 6/6 windows, piers. Vinyl siding added, some 2/2 windows, half of porch enclosed, piers and continuous foundation.
134. Smith-Worthy House (2312 - 38th Blvd.), 1910  
One story clapboard cottage, full width front porch, gable roof, 1 interior chimney, 6/6 windows, piers. Vinyl siding added, some 2/2 windows, piers and continuous foundation.
135. Newsome House (2404 - 38th Blvd.), 1910  
One story clapboard cottage, full width front porch, gable roof, 1 interior chimney, 6/6 windows, piers. Windows replaced with 2/2, asbestos siding added, some piers now continuous.
136. Freeman House (2406 - 38th Blvd.), 1910  
One story clapboard cottage, full width front porch, gable roof, 1 interior chimney, 6/6 windows, piers. Porch now enclosed, 2/2 windows, asbestos siding added, some piers now continuous.

137. Mims-Eiland House (2408 - 38th Blvd.), 1910  
One story clapboard cottage, full width front porch, gable roof, 1 interior chimney, 6/6 windows, piers. Masonite siding added, 2/2 windows, some piers now continuous.
138. Scott House (2410 - 38th Blvd.), 1910  
One story clapboard cottage, full width front porch, gable roof, 1 interior chimney, 6/6 windows, piers. Asbestos siding added, some 2/2 windows, some piers now continuous.
140. Hendrix-Rogers House (2416 - 38th Blvd.), 1910  
One story clapboard cottage, full width front porch, gable roof, 1 interior chimney, 6/6 windows, piers. Rooms added on front and back, half porch, vinyl siding added, 2/2 windows, double carport on side, some piers now continuous.
141. Butts House (2407 - 38th Blvd.), 1910  
One story clapboard bungalow, gable roof, half porch, 2 interior chimneys, 6/6 windows, piers. Original windows replaced with 2/2, some piers now continuous.
142. Jones House (2408 - 37th Street), 1918  
One story clapboard bungalow, 6/6 windows, piers (now continuous), gable and hip roof, full width front porch, one interior chimney, 2 front doors. Windows changed to 2/2.
143. Williams-Prather House (2415 - 37th Street), 1918  
One story clapboard bungalow, 6/6 windows, piers (now continuous), gable and hip roof, full width front porch, one interior chimney, 2 front doors. Asbestos siding added; wing added; lattice windows; porch enclosed; 1 front door removed; room added to side with gable roof.
144. Davis-Parker House (2413 - 37th Street), 1918  
One story clapboard bungalow, 6/6 windows, piers (now continuous), gable and hip roof, full width front porch, one interior chimney, 2 front doors. Vinyl siding added; carport added with shed roof; half porch enclosed; shutters added.
145. Dykes-Ray House (2411 - 37th Street), 1922  
One story clapboard bungalow, 6/6 windows, piers (now continuous), gable and hip roof, full width screened front porch, 1 interior chimney, 2 front doors. Vinyl siding added; room added with gable roof and 2/2 windows; chimney removed; 1 front door removed; indoor/outdoor carpet on screened porch.
147. Gosdin-Palmer House (2406 - 37th Street), 1920

removed; room with shed roof added on back; cement  
back deck; stoop and steps on front added.
339. Meadows-Walls House (2012 - 22nd Avenue), 1908  
One story clapboard cottage, 6/6 windows, piers (now  
continuous), pyramid roof, half width front porch,  
2 interior chimneys. Room added on side under gable  
roof, 2/2 windows replace original 6/6, chimney  
removed, basement added.
340. Maddux-Hammock House (2010 - 32nd Street), 1908  
One story clapboard, 6/6 windows, pyramid roof,  
2 interior chimneys, half width front porch, piers (now  
continuous). Asbestos siding added, 2/2 windows with  
awnings, chimneys removed, room added with gable roof.
341. Miles-Newman House (2008 - 32nd Street), 1908  
One story clapboard, piers (now continuous), pyramid  
roof, 6/6 windows, 2 interior chimneys, half width front  
porch. Room added from front porch, 2/2 windows, chimneys  
removed.
342. Bryan-Howard House (2006 - 32nd Street), 1908  
One story clapboard, piers (now continuous), 6/6 windows,  
pyramid roof, 2 interior chimneys, half width front porch.  
Brick added on front; room added on side with gable roof;  
2/2 windows with awnings, chimneys removed, cement drive  
and walk, wrought iron rails on front, carport added.



343. Wallace-Hollis House (2005 - 32nd Street), 1908  
One story clapboard, piers (now continuous), 6/6 windows, pyramid roof, 2 interior chimneys, half width front porch. Vinyl siding added, room added with gable roof, 1/1 windows with shutters replace 6/6, chimneys removed, stoop added on front, wrought iron railings, cement drive and walk, porch enclosed.
344. Arnold-Lanier House (2004 - 32nd Street), 1908  
One story clapboard, piers (now continuous), 6/6 windows, pyramid roof, 2 interior chimneys, half width front porch. Asbestos siding added, 3/3 windows, room added with hip roof, chimneys removed, cement walk.
345. Miller-Peek House (2003 - 32nd Street), 1908  
One story clapboard, piers (now continuous), 6/6 windows, gable roof, 2 interior chimneys, full width front porch. Aluminum siding added, chimneys removed, shutters added, porch added on side with hip roof.
346. Lackey-Breedlove House (2002 - 32nd Street), 1908  
One story clapboard, piers (now continuous), 6/6 windows, pyramid roof, 2 interior chimneys, half width front porch. Asbestos siding added, 2/2 windows, carport added, asphalt drive, cement walk.
348. Abney-Breedlove House (3205 - 20th Avenue), 1908  
One story clapboard cottage, piers (now continuous), 2 interior chimneys, 6/6 windows, hip roof, full width front porch. Completely remodeled - cottage type, hip roof with added dormers with windows for rooms upstairs; 2/2 windows except for windows on front which are floor to ceiling; small front porch with wrought iron columns. NOTE: House was moved back to widen Highway 29.
349. Jenkins-Sheppard House (2001 - 32nd Street), 1908  
One story clapboard bungalow, piers (now continuous), 6/6 windows, gable roof, 2 interior chimneys, full width front porch. Aluminum siding added, some 5/5 windows, front porch enclosed with glass and brick, room added to back with hip roof, chimneys removed.
350. Lane House (3011 - 20th Avenue), 1908  
One story clapboard bungalow, hip roof with gable roof over front stoop entrance, 6/6 windows, side porch, 2 interior chimneys. Side porch now enclosed; new brick foundation. NOTE: House moved back to widen Highway 29.
351. Jones-Wellington House (3009 - 20th Avenue), 1908  
One story clapboard bungalow, hip roof, 6/6 windows, 2 interior chimneys, gable roof screened porch across front of house with brick and wood columns. Brick piers (now continuous). NOTE: House moved back to widen Highway 29.

352. Edmondson-Cowles House (3007 - 20th Avenue), 1908  
One story clapboard bungalow, hip roof, 6/6 windows, 2 interior chimneys, full width front porch with brick and wood columns. Carport with shed roof added; half of porch enclosed; other half screened. NOTE: House moved back to widen Highway 29.
353. Browning-Laster House (3003 - 20th Avenue), 1908  
One story clapboard bungalow, hip roof with added flat roof louvered dormers, screened porch across front of house, brick piers made continuous, 2 interior chimneys, 6/6 windows. NOTE: House moved back to widen Highway 29.
354. Shawmut Ball Park, a.k.a. Tater Milner Field (25th Blvd.), c. 1915  
Ballpark where Shawmut Mill Baseball Team played home games. It had a grandstand, bleachers, dugouts for home and visiting teams, etc. It was also used for Shawmut School football games. Now used by Recreation Dept. for baseball, football and soccer games.
356. Duffey-Johnson-Edwards House (3104 - 24th Avenue), 1908  
One story clapboard, 6/6 windows, piers (now continuous), 2 chimneys, full width front porch (screened), gable roof, 2 front doors. Vinyl siding added, 2/2 windows, room added on back with shed roof, carport added on side, cement drive, awning added to front porch.

## HISTORY OF SHAWMUT MILL AND VILLAGE

It was in 1907 that the fledgling West Point Manufacturing Company laid plans for a major expansion with the decision to build a large manufacturing division in a rural area between the company's first mill at Langdale AL and its subsidiary facilities in Lanett AL.

The new mill - which was the first in the region whose entire outlay of machinery was run by electricity - was created to bolster West Point's production of heavy duck.

The mill and surrounding village was named in 1908 when Horace Sears, Boston-based Treasurer of West Point Manufacturing Company, suggested Shawmut, the name under which the city of Boston was originally chartered.

Thus, Shawmut Mill Division came into being. The plant was an ultramodern four-story structure 800 feet long and 125 feet wide. Its most modern feature was that its 35,000 spindles and 1,000 looms were all operated by electric power. The hydroelectric plant at Langdale AL was completed during 1908 as well, and a transmission line to Shawmut made it possible for that facility to become one of the first all-electric plants in the South.

One of the mill's first products was heavy belting duck, and one of its first large orders came from the International Harvester Company. Later, the unit produced a wide variety of ducks.

Meanwhile, the village surrounding the mill rapidly took shape. A landscape architect, employed to lay out the village, chose the pattern of a wheel with a large open area in front of the mill as the center, or hub, of the community. Streets were laid in a pattern leading out from the circular hub like spokes in a wheel, radiating down neat rows of homes, playgrounds, and parks.

The community assumed the name of the mill - Shawmut - which is an Indian name meaning "living springs". A school was one of the first public buildings erected, followed closely by churches; a commercial building built as a community shopping center with a drug store, grocery store, dry goods store, and barber shop on the first floor, and a gathering place for indoor activities on the second floor; and an auditorium - all facing the "hub" in the center of Shawmut.

Work remained steady at Shawmut Mill as the market for duck held strong. In 1935, when most of the nation's workers were idled, the people at Shawmut Mill began to experiment with synthetics to help them maintain a commanding position in the field of industrial and heavy-duty fabrics.

Later, machinery was installed in a warehouse and another section of the mill for the manufacture of West Point's first synthetic product: high tenacity rayon belt fabric.

There have been several offshoots from the operation at Shawmut. West Point's "Research Division" originated in 1918 as an outgrowth of some work done with a hand-driven tensile strength machine in the Shipping Room of Shawmut Mill. In 1924, a testing laboratory was built on the mill grounds, and, in 1927, a modern laboratory was added in front of the mill near the main office.

Built in 1907-08, Shawmut Mill was one of the first <sup>Ala. Historical Commission</sup> all-electric manufacturing plants in the South, and Shawmut Mill Village was the first planned village. The pattern chosen for the layout of the village was the wheel, with a large open area in front of the mill as the center, or hub, of the community. Streets were laid in a pattern leading out from the circular hub like spokes in a wheel. The school, churches, auditorium and commercial building were erected - all facing the hub in the center of Shawmut.
