### **Alabama Historical Commission Announces 2026 Historic Sites Grant Program**

**Montgomery, Ala.** – The Alabama Historical Commission (AHC), the State Historic Preservation Office, has opened the application period for its 2026 Historic Sites Grant Program, funded through an appropriation by the Alabama Legislature and Governor Kay Ivey. Eligible historic sites may submit applications beginning February 11, 2026.

The AHC will administer a \$3,600,000 grant program to support capital improvements and educational programming at historic sites and monuments across Alabama.

“Our state’s history is important, and the Legislature realizes this,” said Senator Arthur Orr. “All across Alabama we have sites that remind us of who we are and who we were as a people. Thanks to our partnership with the Alabama Historical Commission, we are able to preserve and maintain elements of our past.”

Grants are available to public or nonprofit entities that own monuments commemorating historical events or places, or that operate sites with a mission centered on historical education. Priority consideration will be given to:

- Properties listed in or eligible for the National Register of Historic Places that were built before 1840 and are publicly owned and accessible
- Properties built in or before 1943 that are listed in or eligible for the National Register
- Properties built after 1943 that made significant contributions to the civil rights movement

Individual grant awards will not exceed \$75,000 and must be expended within two years of receipt.

Last fiscal year, the Historic Sites Grant Program helped facilitate improvements such as roof replacements, window restorations, and exterior painting,” said Lisa D. Jones, Executive Director of the Alabama Historical Commission. “The goal of the 2026 grant program is to assist historic sites throughout Alabama with both preservation needs and educational programming, ensuring these places endure for future generations. We are grateful to the Alabama Legislature and Governor Kay Ivey for supporting this much-needed program.”

Applicants must submit an official 2026 Historic Sites Grant application through the AHC’s Submittable platform. Additional information is available on the Grants page of the Alabama Historical Commission website.
